■ Old Business:

■ **Road Work:** *Nine culverts have been replaced. There were 6 replaced on 690th, 2 on 906th and one driveway culvert by Meyer's brother's grain.*

■ *The crack filling machine will arrive in about a week.*

■ **Abandoned Junk Ordinance:** *The certified letters were mailed on August 11, 2016. One was received and signed for. The other one was returned. The letter that was returned will be resent with the copy of the certified envelope attached to the letter.*

■ **Amended Speed Limit Ordinance:** *Jeff Klemp made a motion to approve the Speed Limit Ordinance to be effective on the day that the signs are installed. Elton J Christopherson seconded the motion. Motion carried.*

■ **Building permit Ordinance:** *The new building permit ordinance was worked on and will be put on the October agenda.*

■ **Manure Ordinance:** *Wisconsin Act 231 states that it is legal to lay manure pipes in the Town Right of Way ditches for the purpose of pumping manure. The Town of Elk Mound will draft an ordinance that will govern the Elk Mound Township concerning manure piping. This will be put on the October agenda.*

■ *Marvin Michels will check on a new fence for the cemetery on the east side.*

■ *Marvin Michels made a motion to prebuy propane at 89 cents per gallon for the upcoming year. Jeff Klemp seconded the motion. Motion carried.*

■ *Fix It Resolution that was recommended by the Towns Association will be put on the October agenda.*
