

**TOWN OF Elk Mound  
Dunn County, Wisconsin  
Resolution that the Proposed Dunn County Land Division Ordinance Update  
Be Returned to the Planning, Resource, and Development Committee  
for Further Review and Public Input**

WHEREAS, the Town of Elk Mound, an un-zoned township in Dunn County, Wisconsin, will be impacted by the proposed changes to the Dunn County Land Division Ordinance;

WHEREAS, public knowledge of and public input regarding the proposed changes to the Dunn County Land Division Ordinance were challenged due to the Coronavirus (COVID-19) Pandemic and the use of a virtual format to conduct meetings and public hearings;

WHEREAS, four of the six un-zoned townships in Dunn County (Town of Elk Mound, Town of New Haven, Town of Rock Creek, and Town of Spring Brook) were in attendance at an informational meeting held at the Town of Elk Mound Hall on April 29, 2021;


WHEREAS, the Town of Sand Creek Chairperson was in contact with the Town of Elk Mound Chairperson for an exchange of information regarding the proposed changes to the Dunn County Land Division Ordinance and the effect upon un-zoned townships;


WHEREAS, four of the six un-zoned townships in Dunn County (Town of Eau Galle, Town of Elk Mound, Town of New Haven, and Town of Spring Brook) were in attendance at an informational meeting held at the Town of Spring Brook Hall on May 10, 2021;

WHEREAS, two of the six un-zoned townships in Dunn County (Town of Elk Mound and Town of Spring Brook) were in attendance at a joint meeting of the Dunn County Planning, Resource and Development Committee and the Land Conservation Committee held in-person and virtually on May 11, 2021;

NOW THEREFORE, BE IT RESOLVED, that the Town of Elk Mound, an un-zoned township in Dunn County, Wisconsin, respectively affirms the discussion and decision brought forward at the May 11, 2021, combined meeting of the Dunn County Planning, Resource and Development Committee and the Land Conservation Committee to direct the proposed changes to the Dunn County Land Division Ordinance be returned to the Dunn County Planning, Resource and Development Committee for further review and public input.

This resolution was adopted at the regular town board meeting held in the Town of Elk Mound of Dunn County, Wisconsin, on May 13, 2021. The resolution passed unanimously by roll-call vote.
